- Please refer to the CKC Schedule of Fees (#100-04-07) for current fees.
- Please submit the original form to The Canadian Kennel Club, along with the *Application for Registration* (or *Certificate of Registration* if the dog is already registered), and an *Application for Transfer* of Ownership.

- This Agreement must be completed in triplicate and signed by all parties to the Agreement on the date of sale or as soon as practicably possible after the sale but no later than the date on which the new owner takes physical possession of the dog.
- This agreement may be cancelled only by the mutual consent of the parties hereto (except where interim sellers have waived their rights).

Such consent must be on the *Consent to Cancellation* form provided by the Club for that purpose. A person who sells as purebred, the progeny of any dog covered by such an agreement at the time of service shall be deemed agreement at the time of service shall be deemed to have violated the provisions of the Animal Pedigree Act. The Consent to Cancellation form together with the Certificate of Registration issued for the dog must be forwarded to the Registration Division at the address noted above.
