TERMS OF SALE OF PUPPY

This contract sets out the only guarantee made by the proprietors of GOLDNOTE GOLDENS, herein after called the seller, and _____ herein after called the purchaser(s).

The seller agrees to sell the purchaser one (male or female) Golden Retriever, tattoo number MR7 ____ for the sum of \$ _____ dollars plus harmonized sales tax at 13% (if applicable) in the amount of \$ _____ for a total sale of \$ _____. Full payment of all costs including payment for the puppy, its shipping and travel costs (if applicable) of \$ _____ and the shipping crate cost of \$ _____ and any additional agreed upon costs of \$ _____ must be received by Bruce Brown of Goldnote Golden Retrievers before transfer of CKC registration to the purchaser will be completed. Payments made in the amount(s) of \$ _____, on this the ____ day of _____ in the year of _____.

This puppy is considered Pet Stock at the time of purchase, has had its preliminary vaccinations, has been inspected by a veterinarian and is guaranteed free from disease for seventy-two (72) hours after removal from Goldnote premises. If Goldnote is to be held responsible for any veterinary fees, Goldnote must be consulted and our advice followed BEFORE treatment commences. We will only take responsibility for veterinary or other service provider fees that are performed by our veterinarian or in the case of other veterinarians, expenses that we agree upon prior to the commencement of treatment.

This puppy is sold with a Canadian Kennel Club NON-BREEDING contract. The seller may consent to cancellation of this contract (costs of cancellation to be paid by purchaser) when the puppy reaches 24 months of age or older providing the following conditions are met.

- 1) The puppy must have a sound temperament.
- 2) The puppy must be certified clear of hip and elbow dysplasia.
- 3) The puppy must be certified clear of PRA or hereditary cataracts or other genetic eye disease.
- 4) The puppy must be free from any heart murmur caused by hereditary disease.

- 5) The puppy must not have any disqualifying faults. These faults are:
 - a) Deviation from height of more than one (1) inch from the breed standard, either way.
 - b) Monorchidism or cryorchidism
 - c) Undershot or overshot jaws. This condition is not to be confused with misalignment of teeth.
 - d) Trichiasis (abnormal position or direction of the eyelashes).
- 6) The puppy must have conformation which meets show standard.
- 7) The puppy must have achieved their Canine Good Neighbour Certification **plus** at least one of the following titles:
 - a) Conformation Championship
 - b) Obedience degree(s) (CD, CDX, UD, RN, RA, RE)
 - c) Working certificate(s) (WC, WCI, WCX)
 - d) Tracking degree(s) (TC, TDX)
 - e) Other previously agreed upon performance titles.

The seller will offer a replacement puppy or full refund in the case of any congenital fault (including hip dysplasia) which causes the puppy to be put to sleep within three (3) years of purchase OR which requires an operation in lieu of euthanasia. Total refunds including medical fees will never exceed the original purchase price of the puppy. Goldnote and its proprietors will not be responsible for veterinary fees or any other costs or expenses that are performed by other veterinarians or service providers without our prior consent. In the case of congenital faults as outlined above we will honour our guarantee regardless of the treating veterinarian provided we are consulted before treatment and diagnostics commence.

No replacement or refund will be offered if this puppy has been used for breeding purposes either deliberately or accidentally.

This guarantee is null and void if this puppy or dog is fed puppy food at any time now or in the future. This guarantee is also null and void if this puppy or dog is spay or neutered before the age of 10 months in the case of females or before the age of 18 months in the case of males.

This is the only guarantee implied or stated.

The purchaser agrees to notify the seller BEFORE this puppy is:

- 1) Sold or otherwise disposed of.
- 2) Entered in any conformation dog show.
- 3) Spayed or neutered.
